Board of Directors' Monthly Meetings

The April meeting of the Board of Directors (BOD) of the Homeowners Association (HOA) was held on Tuesday, the 1st, at 7PM, in the **Conservancy Conference Room** at 4263 Aiken Drive. The regular, monthly BOD meetings are open and all members are invited to attend. At the beginning of each monthly meeting, there is an opportunity for members to make comments and/or present questions for the BOD's consideration, as well as advise concerns, or offer ideas. Minutes of the previous meeting, as well as current financial statements, are made available to all attendees. Significant items addressed at the meeting are covered in the Newsletter.

By keeping up the appearances of our homes, and

continuing to foster the spirit of community, the 'reality' will live up to the pictures, and contribute to the enchantment of visitors and prospective buyers. Not everyone in our demographic wants all the amenities that other 55+ developments offer, along with the significantly higher monthly HOA assessments. We have a niche market and we should be capitalizing on it and spreading the word. Wouldn't it be great if it got to the point where Vint Hill Manor was a buzz word among realtors and we had, in effect, a waiting list of prospective buyers!

Trash Collection and Recycling

The BOD is in the process of considering a number of options connected with the renewal of the trash collection contract with the current contractor, Culpepper Trash Services. In response to a number of inquiries, some of the options being considered include the addition of the collection of recyclable materials, such as: newspapers and magazines, aluminum, glass, and plastics (codes 1 thru 6). As the contract period has already begun, the options are limited to those offered by the current contractor. The contract will be for a two year period and whatever option is selected will apply community wide. Culpepper Trash has advised that they are flexible and would be amenable to change if whatever option decided upon at this time ends up not working

out in the best interests of our community. There will be no change in our current monthly assessments; however, the decision could impact future possible reductions. If the collection of recyclables is added, Culpepper Trash, as indicated above, will provide all homes with a special container for those above mentioned recyclable materials and they will collect them on a separate run, on Tuesdays, with separate equipment (a specially designed

Currently, homeowners who wish to participate in the recycling program have to make trips on their own to remote centers. It is anticipated that having these materials picked up at our homes will result in an increased participation in the program. It also means having an extra container and an additional collection vehicle going through the community on Tuesdays if Option #1 on the enclosed survey is selected.

trailer).

Participating in the recycling program by placing recyclable materials in their special container can/should significantly reduce the amount of 'trash' generated, which could influence a preference for Option #2. The choice of Option #4 may present the least cost; but, the amount of trash accumulated could exceed the capacity of the container. Overflow or extra bags left outside could draw animals and/or lead to refuse blowing around the community.

It should be noted that the collection of recyclables is only done on Tuesdays. Trash collection is done on Tuesdays and Fridays, or on either Tuesday or Friday if either Option 2 or 4 is selected (one trash collection per week).

An informal poll produced mixed results, therefore, the BOD has decided to attempt to get entire community input to assist in making an informed decision. Included in this Newsletter is a separate SURVEY FORM with the full range of options and their related costs. Overall interest in participating in recycling will be indicated by the number of selections for either #1 or #2. PLEASE take time to review the various options and make your preference known - BY MAY 4TH as indicated at the end of the **ENCLOSED** survey.

SURVEY FORM OPTIONS:

#1 Three Pickups – Two Trash (Tue & Fri) and One Recyclables (Tue) @ \$24 per lot per month.

#2 Two Pickups – One Trash (Tue or Fri) and One Recyclables (Tue) @ \$21 per lot per month.

#3 Two Pickups – Two Trash (Tue & Fri) and No Recyclables, which would continue our current contractual arrangement at the same cost, \$19 per lot per month.

#4 One Pickup – One Trash (Tue or Fri) and No Recyclables @ \$16 per lot per month.

legalistic wordsmithing. When presented at the April BOD meeting, discussion ensued regarding the impact that concerns expressed by the attorney could have on the proposals. Frank Fuerst, Chair of the **HOA Chartering Documents Review** Committee, offered to review the wording of the documents, in light of the attorney's findings, and present his findings at the May BOD meeting. Fred Austin, ARMI, raised the need for approval of the proposals by the **Economic Development Authority** (EDA) before they are submitted to the membership for a vote.

Vacant Board Positions

As explained in the Special Notice, dated April 03, 2008, delivered to each home, our community has lost/will lose the direct services

of THREE members of the BOD. In addition to Bob McConahy, whose resignation was reported in the April Newsletter, Anava Grabowski announced her resignation at the April BOD meeting. Following the April BOD meeting, Lynne Pincosy also advised her intent to resign with an effective date subsequent to the meeting that was held on Thursday, April 17, 2008, to fill the TWO vacant positions. Lynne's position will be filled in an Executive Session that will be held during the upcoming May BOD meeting.

Anava Grabowski was selected to fill the vacant position on the BOD created by the passing of her husband, Norbert. Anava's introspective approach always guaranteed in-depth and sufficient

consideration was given to every issue dealt with by the BOD. She personally saw to the arrangements for the last two Annual Membership Meetings, and led the effort to take cautionary measures to preserve the components of our two pocket parks.

Lynne Pincosy, elected to the BOD at the 2007 Annual Membership Meeting, was very instrumental, along with her recently deceased husband, John, in getting our community web site (www. vinthillmanor.org) up and running. She also did a lot of 'behind the scenes' work in obtaining "as built" engineering documents/drawings for the storm water management system in our development, for review. Lynne's passion for landscaping led her to do a lot of research which ended in the contractual arrangements for the improvements at the entranceway off Rogues Road, and for the landscaping that will be done around the raised manholes.

Once again, our community has suffered significant losses. We offer our sincere thanks for the contributions that Anava and Lynne made and hope they will consider some level of continued or future service.

Architectural Review Committee (ARC)

Stan Manvell made his debut appearance, as the newly installed Chair of the ARC, at the April BOD meeting. He announced that a complete review of all the ARC records is underway, comparing the listing of unapproved modifications with actual conditions existing on the lots in question. The numbers reported at the April BOD meeting were 43 unapproved modifications distributed among 24 lots.

The ARC meetings are held on the last Tuesday of the month and, like

the BOD meetings, are open to the members of the community. The meetings are now being rotated among the homes of the members of the ARC. April's ARC meeting will be held at 7PM, on the 29th, at the home of George Mendez, 3661 Osborne Drive.

The ARC continues to be more than ready and willing to meet with any homeowner to provide guidance and/or assistance with the necessary application(s) which are required for exterior modifications to our homes.

Reminders

A number of incidents have been reported of vehicles going through our community at what appear to be speeds higher than the posted 25 MPH.
