President's Column

Monthly Assessment

Your Treasurer, Ed Ortiz, along with other members of the Budget work group, has been reviewing our reserve-growth projections for 2009 and 2010 and decided that we have enough money in reserve. At our last Board meeting, Ed made a motion to apply the expected reserve growth in the 2010 Budget to decrease the Vint Hill Manor HOA monthly assessment from \$50 to \$45, effective January 1, 2010.

This motion passed by a 5-0 margin. For those who do on-line banking, please wait until after your December payment is made to make this change. For everyone else, please jot down a reminder to only mail in \$45 starting January 1.

Outside Lighting

"With the recent prowler scare, this may be a good time to check whether or not your front yard (lamp post) light is working. If it is not, check the wall socket in your garage (the one in the middle of the wall against the house). If the red light is on, the circuit is broken. Press the top reset button of the wall socket to reset. If the red light is not on, the bulb will have to be replaced. Consider a compact fluorescent light bulb so you won't have to change it as often."

Board of Directors' Monthly Meeting

The November meeting of the Board of Directors (BOD) of the Homeowners Association (HOA) was held on Tuesday, November 10, 2009, in the Conference Room at the Vint Hill Conservancy/ EDA offices at 4263 Aiken Drive. The regular, monthly BOD meetings are open and all members are invited to attend.

At the beginning of each monthly meeting, there is an opportunity for members to make comments and/or present questions for the BOD's consideration, as well as advise concerns, or offer ideas. Minutes of the previous meeting, as well as current financial statements, are made available to all attendees. Significant items addressed at the meeting are covered in this newsletter.

Architectural Review Committee (ARC) Activity

Steve Chronister, ARC Chair, advised that during their meeting on October 27, 2009, two design requests were reviewed and approved. Steve also reported that the number of outstanding unapproved modifications had been reduced so that there are now only four lots with five unapproved modifications in a non-compliant status. The ARC is making a concerted effort to address this longstanding situation. The November ARC meeting was scheduled for the 24th, at 7:00PM, at the home of Steve Chronister, 6528 Averbach Court. The ARC meetings are always scheduled for the last Tuesday of the month. The ARC is always ready and more than willing to meet with any homeowner to provide guidance and/or assistance with the necessary application(s) which are required for exterior modifications to our properties. In a spirit of cooperation, please help the ARC reach its goal of complete compliance.

Common Grounds Initiatives

Frank Fuerst, Acting Chair of the Common Grounds Committee (CGC), provided a note of clarification regarding two projects reported as completed at the previous meeting. The two projects were the bare spots between Osborne and Sutherland, and between Osborne and the woods. The contract was for aerating and seeding and did not include watering, as originally recorded.

Regarding watering on two other projects, which was done by the homeowners immediately adjacent to the common ground areas on which the work was done, one bill was presented for a nominal amount of \$13.51, and on the other, the amount was so insignificant, no monetary reimbursement was sought.

Frank indicated the wetlands cleanup project would be pursued next with a goal of completion before the end of the year.

Further action on the development of the Common Grounds Management Guidelines was tabled indefinitely. The intent, however, is to have the Guidelines completed, approved, and in place in time for the Spring season.

At this point in the meeting, Frank had **Ed Ortiz** report on the status of the signage at the community entrance at Rogues Road and Cray Drive. The Vint Hill Conservancy has decided to take the lead in the development of "Sense of Place" signage at all entrances to the overall Vint Hill complex. As a result, the two community HOA's will not pursue any further preliminary design decisions at this time. Once the Conservancy has developed some proposed designs, however, the two HOA's will be invited to review and critique them before any construction is begun. Frank recommended Ed offer a suggestion to the Conservancy to consider that any new signage be, perhaps, something on the order of a scaled-down version of that

which is at the entrance off Vint Hill Road.

2010 US Census - What to Expect/What to Look Out For

For years, the Better Business Bureau (BBB) has educated consumers about not giving out personal information over the telephone or to anyone who shows up at their front door. With the U.S. Census process beginning, BBB advises people to be cooperative, but cautious, so as not to become a victim of fraud or identity theft.

The first phase of the 2010 U.S. Census is under way as workers have begun verifying the addresses of households across the country. Eventually, more than 140,000 U.S. Census workers will count every person in the United States and will gather information about every person living at each address including name, age, gender, race and other relevant data.

"Most people are rightfully cautious and won't give out personal information to unsolicited phone callers or visitors, however the Census is an exception to the rule," said Steve Cox, BBB spokesperson. "Unfortunately, scammers know that the public is more willing to share personal data when taking part in the Census and they have an opportunity to ply their trade by posing as a government employee and soliciting sensitive financial information."

The Census data will be used to allocate more than \$300 billion in federal funds every year, as well as determine a State's number of Congressional representatives. Households are actually required by law to respond to the Census Bureau's request for information.

During the U.S. Census, households will be contacted by mail, telephone or visited by a U.S. Census worker who will inquire about the number of people living in the house. Unfortunately, people may also be contacted by scammers who are impersonating Census workers in order to gain access to sensitive financial information such as Social Security, bank account or credit card numbers. Law enforcement in several states have issued warnings that scammers are already posing as Census Bureau employees and knocking on doors asking for donations and Social Security numbers. The big question is - how do you tell the difference between a U.S. Census worker and a con artist?

BBB offers the following advice:

• If a U.S. Census worker knocks on your door, they will have a badge, a handheld device, a Census Bureau canvas bag and a confidentiality notice. Ask to see their identification and their badge before answering their questions. However, you should never invite anyone you don't know into your home.

Census workers are currently only knocking on doors to verify address information. Do not give your Social Security number, credit card or banking information to anyone, even if they claim they 7. need it for the U.S. Census. While the Census Bureau might ask for basic financial information, such as a salary range, it will not ask for Social Security, bank account or credit card numbers nor will

or credit card numbers nor will employees solicit donations.

• Eventually, Census workers may contact you by telephone, mail or in person at home. However, they will not contact you by email, so be on the look out for e-mail scams impersonating the Census. Never click on a link or open any attachments in an e-mail that are supposedly from the U.S. Census Bureau.

Cold War Museum Update

As reported in the November issue of the *Manor Monitor*, there are plans underway

to establish a Cold War Museum. The latest development is that the site location has changed from Lorton to right here at Vint Hill. There was a detailed article about the Museum in the Times-Democrat on Wednesday, November 11, 2009.The plans call for situating the Museum in the 4,000 square feet of space in what is known as the barn complex. The concentration will be on worldwide events that took place from the end of WWII in 1945 to 1991. The Museum will start off rather modestly; but there are already plans for growth. In addition to the displays and artifacts on the first floor. there will be a reference/research library on the second floor that will have more than 3,000 books on the Cold War and other Cold War related documents and papers. The Museum also will have a small gift shop, where books and novelty items, including pieces of the Berlin Wall, will be available.

Rich Reiss, the Vint Hill Economic Development Director, was instrumental in the decision being made to locate the Museum at Vint Hill. When the deal in Fairfax fell through, Rich and his staff got involved with presenting Vint Hill as a home and headquarters for the Museum. Reiss advised that they are looking for people who worked at Vint Hill. They are trying to collect information about the history of Vint Hill from people who were here at the time.

The Museum's founder and driving force is Gary Powers, Jr, who is the son of the CIA pilot who was at the center of one of the Cold War's most memorable incidents when the elder Power's U-2 spy plane was shot down over Soviet airspace on May 1, 1960. He has been working on developing the Museum concept for about 12 years. Powers said that although he has never lived here, he does have Fauquier County roots in that his mother and grandfather were born in Warrenton.
