Board of Directors' Monthly Meeting

The May 2010 meeting of the Board of Directors (BOD) of the Vint Hill Manor Homeowners Association (HOA) was held on Tuesday, the 4th, in the Conference Room at the Vint Hill Conservancy/ EDA offices at 4263 Aiken Drive. The regular, monthly BOD meetings are open and all members are invited to attend.

At the beginning of each monthly meeting, there is an opportunity for members to make comments and/or present questions for the BOD's consideration, as well as advise concerns, or offer ideas. Minutes of the previous meeting, as well as current financial statements, are made available to all attendees. Significant items addressed at the meeting are covered in this newsletter.

New Trash Service

On June 1, 2010, JD Trash Service will begin collecting our trash and recylables. The cost to the HOA is \$15.80 per household per month. The cost under the previous con-

tract with Culpeper was \$21. Fred Austin advised that ARMI would send letters to all homeowners advising the last day Culpeper would be collecting trash, etc., would be May 25, 2010, and that Culpeper would be collecting their trash containers and recycle bins that day as well. JD Trash has been asked to deliver their trash containers and recycle bins on May 26, 2010. Collection by JD will begin on June 1, 2010.

The packet from ARMI contained a letter of introduction from JD and a detailed listing of things they will and will not collect as trash, as well as a list of items eligible for recycling and examples of ineligible items. In addition there was information about services JD offers for additional charges billed directly to the homeowner.

The transition is designed to be fairly seamless; however, there was some initial reaction to seeing the above referenced detailed listings. One area, in particular, generated a number of calls to Frank; so, he requested Fred Austin get some clarification from JD. The area in question concerned "Dirt, Sod, or Rocks".

Fred reported back that he talked to Jimmy, the manager of this account, and that Jimmy advised that as long as the materials amounted to 20 pounds or less, and were in a bag or bags in the trash container so that it could be rolled up to the truck, it would be no problem. Major excavation, such as the results of having a whole yard dug up, or a particular rock too large for a man to lift, are their main concerns and would be considered too much. Fred added that in another HOA serviced by JD, he is not aware of any problems with this aspect of the contract.

Architectural Review Committee (ARC) Activity

Steve Chronister, Chair of the ARC, reported on the action undertaken at the ARC meeting on April 27, 2010. The ARC approved three (3) Design Review Applications. One of the review applications was for a formerly unapproved awning that was observed during the November 2009 Community Assessment. Currently, there are twelve (12) unapproved modifications throughout the community.

In another action taken at the meeting, the ARC decided to send letters to many of the homeowners that have had storm doors installed without prior ARC approval. In addition to advising the homeowner that the installation of their door is, as yet, unapproved, the letter will include a Design Review Application with a prefilled storm door description. Instructions also will be provided to assist the homeowner in filling out the application, as well as offering the services of the ARC to facilitate the process. The homeowner will be asked to return the completed application to the ARC or to ARMI. and the letter will reiterate the ARC meeting information, i.e., at 7PM on the last Tuesday of the month at the home of the Chair of the ARC, at 6828 Averbach Ct.

The ARC is always ready and more than willing to meet with any homeown-

er to provide guidance and/or assistance with the necessary application(s)

Common Grounds

Frank Fuerst reported on the Common Grounds Contract. He had performed an inspection and reported the grounds look better than they did last year.

Under Common Grounds Projects he reported one bid was received for \$1796 for the floodplain in relation to the wetlands. New specifications have been sent out since the one bid does not appear to do enough to correct the problem. Bettie Pell explained about the problem and what has been done in the past to try to correct it. She agrees with some of the plans; but does not think it will solve all the problems. The BOD will continue to check out options before proceeding.

The other problem discussed concerned consideration of the contribution homeowner sump pumps may be making to the standing water in yards between Sutherland Ct and Shugart Ct. Again the BOD will check out options before proceeding with attempting to correct this problem.

Programs

Mark Melancon, Manager of the Programs Work Group, reported on the status of ongoing and future programs:

Power Washing – Picking up from the work done last Fall, there were still about 8 homes to be done at the time of the meeting.

Irrigation Turn-On – This was accomplished on April 24, 2010.

Driveway Sealing – Thus far, 11 homeowners have expressed interest. Academy has the best price.

Termite Control – Thus far, about 9 homeowners have expressed interest.
