Board of Directors' Monthly Meeting

* The January 2011 meeting of the Board of Directors (BOD) of the Vint Hill Manor Homeowners Association (HOA) was held on Tuesday, the 3rd, at 7PM, in the Conference Room at the Vint Hill Conservancy/VHEDA offices at 4263 Aiken Drive. The regular, monthly BOD meetings are open and all members are invited to attend.

* At the beginning of each monthly meeting, there is an opportunity for members to make comments and/or present questions for the BOD's consideration, as well as advise concerns, or offer ideas. Minutes of the previous meeting, as well as current financial statements, are made available to all attendees. Significant items addressed at the meeting are covered in the Newsletter.

New Trash and Recyclables Containers – WHEELS TO THE CURB!!!

Recently as (hopefully) everyone knows, County Waste took over the contract previously held by JD. On Tuesday, January 31, 2012, County Waste provided every home in our community with a new '*small-size*' (35 gal) wheeled container for Recyclable Materials, and collected the Blue Bins previously used for this purpose. The company also provided a packet of informational material with each container. *Please read the material in the packet, especially the listing of acceptable and non-acceptable materials for recycling.*

PLEASE do NOT put items in the Recyclable Materials Container in '*plastic bags*'. Just dump your paper, cans, bottles, etc., loosely and freely into the container. Remember, from now on, RECYCLABLES COLLECTION DAY IS FRIDAY.

On Tuesday, February 7, County Waste will provide every home in our community with a '*large-size*' (95 gal) wheeled container for Trash and will provide another packet of informational material. They also will collect any large green containers, previously used for Trash, that are out at the curb.

So, whether you have Trash to be collected or not, or even if you have a little bit of Trash, put the old, big, green container out on Tuesday (2/7/12), with Wheels to the Curb.

In addition to the information about the County Waste Programs, the packet contains a phone number to call to arrange for a different size container FOR EITHER TRASH OR RECYCLABLE MATERIALS. In other words, we can get a <u>larger</u> container for Recyclables, or we can get a <u>smaller</u> container for Trash.

For those residents who were not home when the new Recyclable Container was delivered and/or will not be home when the new Trash Container is delivered, just put them out for collection at the next appropriate opportunity – in other words, if you still have your Blue Bin, put it out next Friday or any succeeding Friday. If you still have

your big green container after Tuesday (2/7/12), put it out the following Tuesday or any Tuesday thereafter.

Please remember, in order to accommodate the new 'automated' collection system, it is important for the containers (both the Recyclables Container and the Trash Container) to be placed at the curb correctly so that the mechanical arms can grasp the containers and dump them into the respective truck. There is information inscribed on the lids; but, the easiest way to remember how to situate the containers is WHEELS TO THE CURB!!!

Finally – and this is just a suggestion/observation – it is probably NOT a good idea to place either container (or vehicle, for that matter) anywhere in close proximity to the mailbox in order to preclude any interference with the delivery of mail. Use the curb space on the opposite side of the driveway.

Security Reminder

Keep your vehicles, that you park outside, locked at all times. Recently one of our residents, upon leaving her home, surprised a youth that was in her vehicle and who, when discovered, ran off in the direction of one of the other Vint Hill communities. This and other incidents of vehicle break-ins, that have been reported in the past, seem to be random and would fall in the category of 'crimes of opportunity'. So please remember to keep your vehicles that are parked outside – even if in your own driveway – locked at all times.
